# Notice on the management of the daily limit for transfer to other accounts not registered under the ATM card in same currency and "EPS" or "UnionPay" POS transaction

With effect from 28 December, 2023, Chiyu Banking Corporation Limited ("the Bank") customers can manage the daily limit for transfer to other accounts not registered under the ATM card in same currency, and "EPS" or "UnionPay" POS transaction. Details are as follows:

# ATM Card Daily limit for POS transaction and transfer to not registered under the ATM card:

Remark 2: The daily limit for transfer to other accounts in same currency and "EPS" or "UnionPay" POS transaction is based on HKD or RMB depending on the currency of transaction.
