

Notification on Termination of BOC Credit Card "Chiyu Bank Sub-Account Service"

October 2023

From 28 December 2023 ("Effective Date"), the savings/current account(s) of Chiyu Banking Corporation Limited ("Chiyu Bank") will be removed from the BOC credit card(s) emblazoned with Chiyu Bank's logo issued by BOC Credit Card (International) Limited (the "Company"). Starting from the Effective Date, you will not be able to access your Chiyu Bank savings/current accounts using the above BOC credit card(s) for transactions including but not limited to cash withdrawals, cash deposits and balance enquiries. Registered services connected to your Chiyu Bank savings/current accounts (including but not limited to PPS service, Hong Kong Jockey Club EPS Instant EFT service, Hong Kong Jockey Club cash voucher purchase, etc.) will also become invalid from the Effective Date, and such transactions will be rejected.

To avoid service disruption, please visit any Chiyu Bank branch to apply ATM card(s) as soon as possible for free and re-register related services (if applicable). For inquiries on Chiyu Bank ATM card application, please call Chiyu Bank Customer Service Hotline on (852) 2232 3233.

For PPS service, please bring the Chiyu Bank ATM card to any PPS Registration Terminals and select the "Open Account" function to create a brand new PPS account. Subsequently, you will need to delete all bills registration from your original PPS account and re-register to your new PPS Account. For enquiry, please call PPS hotline at (852) 2311 9876.

For Hong Kong Jockey Club EPS Instant EFT service and Hong Kong Jockey Club cash voucher purchase service, please bring the Chiyu Bank ATM card to any Off-Course Betting Branches and re-register the related services through the Self-Vending Terminals.

In response to the service adjustment, please be informed that Chiyu Bank's "General Banking Services Charges", "General Information" and "Supplemental Information On Renminbi Services" have been amended and effective from 28 December 2023 ("Effective Date"). Please find attached table 1, table 2 and table 3 for the amendment details.

Please note that you will be deemed to have agreed to the above amendments and will be bound by them if you continue to maintain Chiyu Bank account(s) and/or use or retain any of Chiyu Bank banking, financial or other services on or after the Effective Date. Please also note that if you do not agree to the above amendments, Chiyu Bank may not be able to continue providing services to you. Only the revised "General Banking Services Charges", "General Information" and "Supplemental Information On Renminbi Services" (incorporating the said amendments as aforementioned) can be downloaded on or after 28 December 2023.
- Customers can also download this customer notice from "What's New" on Chiyu Bank website on or before 30 June 2024 and customers may not be able to access or download such customer notice afterwards.

Remarks:

For transaction conducted via the "VISA/PLUS" network through bank account, the transaction amount withdrawn is converted into Hong Kong dollars at the daily exchange rates set by VISA at the time of the transaction plus 1.95% conversion charge (Exchange rate can be enquired via the website of VISA).

For transaction conducted via the "MasterCard/Cirrus" network through bank account, the transaction amount is first converted to US dollars, and then to Hong Kong dollars, at the daily exchange rates set by MasterCard at the time of the transaction plus 1% conversion charge (Exchange rate can be enquired via the website of MasterCard).
